

Season Ticket Member Benefit Card Sweepstakes

Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. BY PARTICIPATING IN THE SEASON TICKET MEMBER BENEFIT CARD SWEEPSTAKES ("SWEEPSTAKES"), PARTICIPANT AGREES TO BE BOUND BY THESE OFFICIAL RULES, THE CLEVELAND BROWNS PRIVACY POLICY FOUND [HERE](#), AND THE DECISIONS OF SPONSOR, WHICH SHALL BE FINAL IN ALL RESPECTS.

1. **Eligibility:** The Season Ticket Member Benefit Card Sweepstakes (the "Sweepstakes") is open to all legal residents residing in the United States who are 18 years of age or older as of date of entry. Cleveland Browns Football Company LLC ("Sponsor") is located at 76 Lou Groza Blvd., Berea, OH 44017. Employees of Sponsor, Cleveland Browns Stadium Company LLC, the National Football League, its member professional football clubs and each of their respective parent, affiliates, subsidiaries and advertising and promotion agencies (collectively, "Released Parties") and their immediate family members (parent, child, spouse, sibling and their respective spouses, regardless of where they reside) and members of their households, whether or not related, are not eligible to enter or win. All applicable federal, state and local laws apply. Void where prohibited.

3. **How to Enter:** During the applicable Entry Period, receive one (1) Official Entry Form by either (i) presenting your Season Ticket Member Benefit Card when making approved concessions or merchandise purchases at either (a) the Browns' official Training Camp in Berea, Ohio, (b) FirstEnergy Stadium in Cleveland, Ohio, or (c) <http://shop.clevelandbrowns.com> or by (ii) mailing a postcard with proper postage affixed to Season Ticket Member Benefit Card Sweepstakes, c/o Cleveland Browns, 76 Lou Groza Blvd., Berea, OH 44017. Any postcard(s) submitted must be legible and contain the following information: the entrant's full name, address, and phone or email, and the one (1) Entry Period the entrant is to be entered into. Each entry must be received by 11:59:59 pm ET of the Entry Period to be eligible. In the event of a dispute as to the identity of an entrant, entry will be awarded to the person named on the Official Entry Form provided such individual is eligible according to these Official Rules. Released Parties are not responsible for late, lost, stolen, incomplete, illegible, inaccurate, misdirected, undelivered, damaged, or destroyed entries, and such entries may not be considered by Sponsor or Released Parties. No purchase or payment of any kind is necessary to enter or win. A purchase will not increase your chance of winning. The use of script, macro

All Prize winners will be selected by 11:59:59 pm ET on 1/5/2018. Sponsor will contact the potential winner via phone or email. The winner will be selected by a panel of judges determined by Sponsor in its sole discretion. Potential winners will be required to execute and return an Affidavit of Eligibility, Liability and Publicity Release prior and as a condition to receiving any prize. Noncompliance with these Official Rules, the inability of Sponsor to contact the potential winner within a reasonable time period or prize or prize notification being returned as non-deliverable may result in disqualification and, time permitting, and at Sponsor's sole discretion, an alternate winner being selected.
